### Dear Johnette,

Over the weekend, I heard a story about woman in Texas who feels forced to take a job in a city she does not want to live in because it pays better than anything she can find in Austin. Sadly, this woman doesn't have much of a choice because she owes the federal government \$340,000 in student loans.

While that amount is not representative of what most debtors owe, it provides a glimpse into the amount of student loans available to students regardless of need. Financial aid counselors at local schools are full of stories about students borrowing excessively for cars, boats, and even cosmetic surgery. If the students are eligible for the money and want it, the schools can't stop them.

That's why I was pleased to see that The American Council on Education sent a letter to Congress this week supporting more authority for schools to set borrowing limits based on common sense variables. This suggestion, along with many others, will be considered by Congress as they begin hearings on reauthorization of the Higher Education Act.

## National Higher Education News

- President Obama is expected to sign a bill this week that would tie student loan rates to the 10-year Treasury. This takes subsidized loans from 6.8% to 3.8% for this fall, but long term there are no assurances they won't climb back up. The cap is set at 8.25%. ***U.S. News & World Report, 08.05.13***
- The Education Committee in the U.S. House of Representatives has requested input on how to improve the Higher Education Act. The American Council on Education submitted suggestions on behalf of 40 college and accreditation associations. ***Acenet, 08.02.13***
- Chancellors and Presidents from 160 universities sent a letter to Congress asking them to increase their support for higher education. Tulane's Scott Cowen was among those signing. "The federal government's partnership with universities has, to a great extent, built our country as we know it today." ***The Advocate, 08.05.13***
